

LRC Meeting Minutes

November 29, 2021

Call to Order: 7:15 PM

Attendance: George, Dick, Jason, Charis and Trina

Minutes: Previous months minutes were read. There was clarification between Open Ranch Bronc and Circuit Ranch Bronc Riding. Circuit Ranch Bronc is for 21 years and younger only. Open Ranch Bronc is for any age, but the points won't go towards the circuit points and they cannot enter circuit ranch bronc and open ranch bronc. Must be one or the other.

Treasures Report: Main account we have \$18,695.11 and the Royalty account has \$379.71.

Old Business:

3rd Quarter Audit: Jason approved the 3rd quarter audit. The only difference found was for last month and it was a payment that was made to buy the Buckles. We still have the two outstanding checks. Charis is working on changing the format to match the audit.

2022 Rodeo: The rodeo date is for June 25th 2022. When we advertise for the rodeo we need to make sure there is a difference between the Open Ranch Bronc Riding and the 21 & Under Circuit Ranch Bronc Riding.

Royalty: Ashlee typed up the Royalty contracts and rules which were read at the meeting. Charis moved that Ashlee be a debit card user for the Royalty account; Jason 2nd a vote was taken and passed. The expectations of the rodeo queen should/ could be outlined in the contracts. One of the expectations that was brought up for discussion was to offer the girls scholarships as an incentive and will get the remaining funds at the end of her reign. It was tabled to ask Ashlee a few questions she may want to add to the contract/ rules. These questions are If the rodeo Queen does not meet these expectations, then some sort of consequences may be taken place. Rodeo club is willing to help with transportation, money upon request. Should there be an exit review? Have the applicants write a brief Bio, so then the bio is already gathered for a newspaper article and for the day of the rodeo. A motion was made to buy a new leather Princess Sash and to have repairs done on the crowns. There was a 2nd and a vote was taken. The motion passed.

Town Meeting: Jason agreed to go to the town meeting in January.

Auction for 2022: Is on February 12, 2022 and we will be having it at the Oasis. We need to get donation letters and the list out ASAP.

Electric Eye: The electric eye itself is \$800. The marquee to display the times is \$1400 (I believe it's like a 48"). We did want to know if it was programmable to add contestant names as

well. George was going to visit with the representative and let them know he had been approved for a \$2000 budget and see if they would deal with us on the price a little.

Buckles: There were two buckles with errors on them. They are being fixed. Next year we plan on ordering them on Black Friday.

Youth Rodeo: Charis visited with Christen Grant about putting on a youth rodeo and or a ranch rodeo; with our help and support. Christen did say they may be interested in working with us. Charis is going to touch base with her and see what they are thinking.

Play Day Once a Week: Will wait till the spring and summer. Charis will get it started for June, July and August. Have an end of season play date.
