Call to Order: 7:04 pm

Minutes: Charis moved to approve the minutes as read, there was a second the motion passed.

Treasurer's Report: Our main account has \$94,420.90 and our Royalty account has \$701.99. We have not received a bill from the Lovell Chronicle for the auction ad. There are two outstanding checks, one for Andy Schawb and one for Buck Wyld. Charis brought up the idea of getting a Certificate of Deposit for some of our funds. Jason moved to approve the treasurer's report, there was a second the motion passed.

Old Business:

ADA bathroom, no new updates.

Auction recap: Our gross income was \$39,962.91 and our net income was \$36,070.57. The card deck raffle brought in \$6,400.00, we had \$1,060.00 in donations. Both WYTEX and 4 Corners said they did great. We are thinking that maybe next year we have a minute break during the auction so that way we can also bid on silent auction items. We need to be more courteous of work hours when dropping off items for the auction at the bank. It was discussed that during 8:00-5:00 Charis and Marlene are on bank hours and that maybe they can receive items for the action after those hours or have a contact person who can receive items during the day. We also talked about maybe putting the banners up for the auction a month in advance. Once we place the banners, general public members bring in auction items. We can always use the car-go- box to hold items until we need them for the auction. Marlene moved to buy 2 more banners and 6 panels, Cody 2nd and the motion passed. We also talked about how we need to remember little things like table clothes. Marlene moved to buy a case of round table clothes and a case of rectangle table clothes there was a second the motion passed. Overall, the auction went great again.

Arena Lights: The price has dropped to \$15010.00. Charis did give the quote to Wayne Brost, and he is taking it to the Motor Sports Board meeting this Thursday.
