Minutes: Marlene read the previous months minutes, Wayne moved to approve the minutes, there was 2nd the vote passed.

Treasurers Report: The royalty account has \$831.37; the main account has \$49,175.31. The radio and newspaper have not sent a bill for advertising the auction. On the card raffle for the rifle, we made \$5300.00, and the auction made \$18,985.00. the net income from the auction is \$24285.00. 10% will go to the royalty account.

Chase the Ace fundraiser net income is \$548.47, and the gross income is \$1362.49.

We are sending a \$500.00 check to Paisley to help with her medical fees, and we spent \$1025.00 at her fundraising auction.

Marlene moved to accept the treasurers report, there was a second, the vote passed.

Old Business:

The auction went great. We have outgrown the Oasis.

Rodeo Food Guys will buy the food and they want to do a 90/10 spilt. If they make good money, they will donate more to the Rodeo Club. Charis moved to have Get Smashed at a 90/10 spilt for the rodeo, there was a second, the vote passed.

Roller Harrow has been fixed for \$300.00

Anniversary buckles have arrived.

Insurance coverage is still being worked on. We are going to talk with the golf course and see what their insurance coverage is and how it works. We might have to buy two different kinds of insurance coverage. Trina said she would call the golf course and Jason said he would talk with Tom Newman

JW Kinder will be our announcer for this year's rodeo, he has sent us a letter of commitment.

The search and rescue will be our gate help this year at the rodeo. There is no derby.

For our Royalty this year, we are only going to have a Queen and a Princess. The Queen will not be able to run consecutive years. The queen contest is April 27th at the arena. Exit interview for the 2023 Royalty will be at the March monthly meeting before the meeting starts.

New Business:

Circuit meeting is 3/26/24. They will be voting for officers. Jason is withdrawing his Vice President nomination. The circuit finals will be September 14, 2024 in Basin. Circuit contestant cards can be purchased the day of the rodeo. Youth cards are \$20.00 and adult cards are \$40.00. There is also a gun raffle for the circuit and it's a 45/70 raffle. For Circuit sponsorship a banner is \$250.00, banner and flag is \$500.00 and banner, flag and your logo on a saddle is \$1000.00. There was motion moved to have a chute boss for every rodeo and said boss will be the same at all rodeos. Lovell does not want this. We have our own chute boss/ arena director.

Chase the Ace, we need to reach out to Charis to help her. Wayne moved to have a radio ad run for the next month to advertise Chase the Ace, there was a 2nd, the motion passed.
