Call to Order at 7:11

Attendance: Wayne, Charis, Oakley, Trina, Cody, Devan Q., Marlene, and Jason

Minutes: Marlene read the previous months minutes, Charis moved to approve the minutes as read there was second the motion passed.

Treasurer's Report: We have \$60,364.79 in our main account and \$642.55 in our Royalty account. At our last meeting we had 5 outstanding checks and 1 pending debit card charge for the Casino in Vegas for our NFR trip winner George Ward. It will cost us \$525.00 to reserve the community center. All rodeo checks have cleared. Keele Sanitation was \$492.50 that was for our one port-o-potty we use from May until October. Trina moved to accept the treasurer's report, there was second the motion passed.

Old Business:

Royalty: Charis reached out to the fairgrounds about renting the indoor arena for the contest; she was told they would call her back. We will keep a look out for other accommodations if we cannot get the indoor arena.

ADA Bathroom- Charis spoke with someone else about grant writing help. They agreed to talk more about it later.

Auction: Garret Linebaugh will cater again for the event, the community center is reserved for February 7th. Andy will not be able to be our auctioneer on the 7th but has January 31st open; Charis is going to see if we can reserve the center for January 31st and let us all know via text. If not, Andy will give Marlene a list of auctioneers. Buck Wyold said they are good to be our band again this year for the auction. Donation ideas are due by January 15th. Charis will ask 4 corners if they would like to be the bar.

Shelves for the car-go box: Marlene moved to buy 2 sets of shelves from Wal-Mart there was second the motion passed.

Tractor serviced: Kolt will take care of this and it will be at mechanical masters.

Service charge: Service account at Sinclair is set up

Buckle options: We voted on a buckle option for the 2026 rodeo season. Marlene moved to purchase on the buckle that won the vote there was second the motion passed.

New Business

Arena lights: Cody found solar lights. They are roughly \$17,000.00. Charis is going to talk with Wayne Brost and see what he thinks and if the motor sports board will be able to help or not.

New Barrier: Trina moved to buy another barrier, there was a second the motion passed.

Maintenance list: Chute improvements

Roping Dummy: Charis is going to reach out to a guy in Gillette to see if he has a calf and steer dummy with prices. She will let us know via text.

Rodeo Announcer: Jeff Campbell will not be able to announce our rodeo this year. Bill Price emailed us about announcing. We are going to look into him along with other options.

Rodeo Band Options: Charis is going to send out a link to the group text from Wild Wind. They are a band that played last year at Worland rodeo.

By laws: 1st reading of Article 6 section A. We want to change: elect in even years to serve odd years and elect in odd years to serve in even years.

2nd reading of Article 6 Section A will be held at the November meeting. After the auction we will go back through the rest of the by laws and see what needs to be changed or not.

Circuit meeting: There were not enough members present for quorum to be met at the last circuit meeting; meaning they could not vote. Trying to find another location to hold the meetings in Greybull. The next circuit meeting is November 18th at 6:30.
